The position to be filled is aimed at recruiting a person able to take charge of a teaching and research mission with the aim of contributing to the implementation of the CYRCE Call for Expression of Interest. The contract is for a period of one year, renewable twice (i.e. 3 times 12 months) to cover the period from 01/09/2025 to 31/08/2028.

Objectives in terms of pedagogical content and supervision:

The aim of this recruitment is to implement the CYRCE (Campus universitaire caennais de cybersécurité) call for expressions of interest.

The person recruited will teach general private law (lecture courses, tutorial and seminars) at bachelor's and master's level, or as part of preparation for competitive or professional examinations.

In addition, depending on their profile, they will also teach digital law. He or she will also be expected to participate in the teaching of the Artificial Intelligence Law Option in the law degree program. The person recruited will participate in the coordination of this module. In addition, he/she will be expected to contribute to the smooth running of the "Cybersecurity Law and Management" DU, due to open in 2026.

II.RESEARCH PROFILE:

Theme/Project:

The teacher-researcher recruited will be attached to the Institut caennais de recherche juridique (ICREJ - UR 967) and in particular to the "Droit, science et numérique" axis. Ideally specialized in digital law (cybersecurity law, cybercrime law in particular), he/she will contribute to setting up or carrying out research work initiated by ICREJ in this discipline.

Recruitment objectives:

The teacher-researcher recruited will be involved in ongoing research projects relating to digital law. An appetite for collective and interdisciplinary research is expected, in particular with computer science colleagues (Laboratoire GREYC).
